

Privacy Policy

Protecting your private information is our priority. This Privacy Statement applies to 2550 Tracy Rd, Northwood, Ohio 43619, and Peacemaker Coffee Company, LLC. and governs data collection and usage. Collection of your Personal Information

To better provide you with products and services offered on our Site, Peacemaker Coffee Company, LLC. may collect personally identifiable information, such as your:

- Mailing Address
- E-mail Address

We do not collect your personal information unless you voluntarily provide it to us. Sharing Information with Third Parties

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
